This year saw significant growth in the fintech segment on the back of retail and MSME credit demand and pandemic-driven physical constraints. Introduction of norms for differentiated segments and increased regulatory scrutiny caused operational disruptions but cracked down on unscrupulous lending practices.

It also saw new initiatives in digital payments and the launch of ONDC and 75 Digital Banking Units with a focus on customer centricity, financial inclusion, increased

accountability and transparency.

DECLINE IN FUNDING

On the other hand, the fintech industry witnessed a 57 per cent decline in funding, leading to a shift towards building sustainable organisations that thrive in challenging funding environments and create value for all stakeholders, said Gaurav Chopra, Founder and CEO of IndiaLend.

Going into 2023, the focus then will remain on customer experience, improving finan-

cial adoption, said Deep Modi, founder of Spice Money.

Even as concerns around additional guidelines will persist owing to increased regulatory intervention in 2023, industry participants expect the influx of new players to continue — especially in retail segments such as insurance intermediation, wealth management and personal loans.

IFC has given a \$400-million loan to HDFC to boost green affordable housing finance in India. IFC's funding will support the country's shift toward a more sustainable growth path, creating jobs and ensuring long-term business growth, as per a statement issued by the two entities.

"A new investment will help close the urban housing gap and improve access to climate-smart affordable homes in India... IFC's funding will help HDFC especially focus on its green affordable housing portfolio, with 75 percent (\$300 million) of the proceeds earmarked for this sector," according to the statement.

Additionally, the lending framework will set rigorous standards for green buildings, allowing HDFC to boost a quality green housing pipeline while channelling funds to this segment.

Most importantly, IFC's financing package will enable the company to on-lend to borrowers, ensuring they can afford such housing, the statement said. IFC (International Finance Corporation) is a member of the World Bank Group.
